Warden Habinski welcomed everyone to the Inglenook Community Hall, where Municipal Council marks the 19th year of celebrating African Heritage Month in that community.

Upon motion of Councillor LeBlanc, seconded by Councillor Gunn, the agenda was approved as amended. Motion carried unanimously.

Minutes

MOTION 170221.01 Minutes Regular Session January 17, 2017

It was moved by Councillor Fowler, seconded by Councillor McNeil, that the minutes of the Regular Session held on January 17, 2017, be approved as circulated. Motion carried unanimously.

Councillor Comments

District 4 – Councillor McNeil said it was an honour to be in the community of Inglewood where his father was a councillor in the 1970s. He appreciates the invitation.

- District 8 Councillor Gunn attended several fundraising meals, the Robbie Burns Supper, and African Heritage Month celebrations in Annapolis Royal. The community mourns the loss of Celia Hearn, who, along with her husband, hosted barn dances that were 'good will offering' for entry and the funds raised (tens of thousands of dollars) went directly towards the needy in the community. The Bear River Cherry Carnival was a huge success and had lots of participation. He received and returned many calls concerning dangerous roads in District 8, and has had lengthy conversations with concerned citizens regarding the amount of clearcutting in the district.
- *District 5* Councillor Heming pleased to be in Inglewood and appreciates the invitation. This is what democracy looks like! He noted Council will hold three Town Hall meetings at various locations throughout the year.
- District 10 Deputy Warden Roberts expressed her pleasure in being in Inglewood again; it is a homey, hospitable environment. She spent the weekend at the Annapolis County Fire Services Symposium at the Centre of Geographic Sciences, Lawrencetown a great job, good information, enjoyable.

District 11 – Councillor LeBlanc expressed her pleasure in being in Inglewood again. She attended the Fire Department banquet in Kingston; their membership consists of firefighters with 30 or more years of service to new volunteers who spend many hours away from their families. Transportation Infrastructure Renewal workers have been busy over the past few months keep us safe, and deserve our thanks for keeping us safe. Councillor LeBlanc moved, seconded by Councillor McNeil, to amend the wording to end after 'generations'. Motion carried unanimously.

They are excited for this year's upcoming House & Garden Tour featuring built heritage in the Annapolis Royal area, including a house from 1867.

The Gardens have been invited to participate in MosaiCanada 150, a major exhibition of mosaiculture funded through Canadian Heritage. It is a very large display of mind-blowing sculptures made from wire and plants. They are the Nova Scotia component and are partnering with NSCC on the project. The theme for the Nova Scotia entry that will come back to reside at the Gardens is a Lobster Fisherman, something that all Nova Scotians can identify with as part of their heritage.
