Direction of the Minister under a Declared State of Emergency

(Section 14 of the *Emergency Management Act*) 20-008

Under my authority in Section 14 of the Emergency Management Act, I order that this Direction (20-008) repeal and replace the Direction regarding municipal meetings issued on March 22, 2020.

During the Provincial State of Emergency declared on March 22, 2020, and under the authority provided to me in Section 14 of the Emergency Management Act, in addition to any other directives I have issued and not repealed or otherwise terminated, I direct that all municipalities and villages in the Province:

1. Effective at 8am on July 29, 2020, may hold meetings exclusively in person if all the following conditions are met:

i) the total number of persons present does not exceed a gathering limitation imposed in a *Health Protection Act* order;

ii) all physical distancing requirements or other requirements imposed in a *Health Protection Act* order are met.

2. If the conditions set out in (1) cannot be met, the municipality or village must not hold meetings exclusively in person and must instead hold the meeting partly or wholly as a virtual meeting by video or telephone, and ensure that all of the following conditions are met:

i) the total number of persons present for any in person portion of the meeting does not exceed a gathering limitation imposed in a *Health Protection Act* order; and

ii) for any in person portion of the meeting, all physical distancing requirements or other requirements imposed in a *Health Protection Act* order are met.

For clarity, this direction does not apply to statutorily required meetings of electors for a village commission which are covered under Direction 20-007 issued on May 20, 2020.

Despite this direction, municipalities and villages are still authorized to continue making other operational decisions especially those required for service delivery.

Please note that these directions are in addition to any requirements established in a Medical Officer's order under the *Health Protection Act*.

A failure to comply with this direction could result in a summary conviction with fines between \$500 to \$10,000 for individuals and up to \$100,000 for a corporation per incident.

This direction will remain in place for the duration of the Provincial State of Emergency unless it is terminated in writing by me earlier.

To the County of Annapolis:

The Annapolis Community Health Board (CHB) is an official endorser of the national Coalition for Healthy School Food, and we are writing today to invite you to join us in calling for a universal healthy school food program.

The Annapolis CHB is a provincially-legislated volunteer advisory group that works to improve health & wellness where we live, work, play and learn. We engage our local community in addressing factors that affect health & wellness including income, food security, housing, and sense of belonging, among others. The Community Health Board advocates for actions to promote and improve health & wellness based on what our community says is most important. We spoke with Annapolis County residents in the development of our Community Health Plan, where food security was identified as one of four priority areas that impact the health of our communities.

All students need access to good food to fuel their minds and bodies, but many students come to school without food for many reasons - long commutes, early morning practices, not being hungry when they wake up, busy family routines, and household food insecurity. Grassroots organizations, charities, and provincial and territorial funding enable one in five children in Canada to access a school food program - **YET Canada is the only G7 country without a national school food program**.

A universal, cost-shared healthy school food program is imperative to help the following issues:

Help kids reach their full potential in the classroom and in life.

Nova Scotia research has identified a strong association between diet and academic performance. Without proper nutrition, children and youth's learning and skill development is significantly impaired.

• Curb rising rates of chronic disease.

1 of every 3 Nova Scotians are not getting enough vegetables and fruits, dramatically increasing their risk of developing chronic life-changing diseases, such as diabetes and heart diseases.

Support the local economy and environment.

Our food choices impact more than our bodies, they impact our economies and our environment. Purchasing from local farmers and food producers supports local economies, decreases greenhouse gas emissions by reducing distances our food travels, and enhances awareness about eating sustainably for people and the planet.

Good nutrition impacts children's health, well-being, and learning. If children are not adequately nourished during childhood, the impact can last a lifetime. Hunger in childhood has long-term adverse consequences for health.

The City of Toronto has confirmed an investment in student nutrition programs, and passed a motion to "support the ongoing efforts of the Coalition for Healthy School Food to advocate for a universal healthy school food program based on the shared belief that all children and youth should have daily access to healthy food at school." They have also been joined by other cities including Victoria, BC and Vancouver, BC.

The Coalition for Healthy School Food is urging municipal governments across Canada to pass similar motions. "Municipal governments can play a crucial role in advocating for universal school food programs," said Debbie Field, Coordinator of the Coalition for Healthy School Food. Developing a Healthy, Universal, Cost-Shared School Food Program for Canada

A successful Canada-wide School Food Program will be:



Health-Promoting

Serve tasty and culturally appropriate whole foods, focusing on vegetables and fruit in line with the revised <u>Canada's Food Guide</u> that models healthy eating habits.



Universal

Ensure that ALL children in a school can access the program in a non-stigmatizing manner. Over time, all children in Canada will participate in a school food program.



Cost-shared

Use federal funding to both expand on current provincial, city, parental and community funding and to initiate new programs in a cost-shared model.



Flexible and Respectful

Successful school food programs reflect the context of the school and region. Ensure that funding supports different food service models, from breakfast to lunch to snacks. Programs should respect local conditions, be culturally appropriate and locally adapted.



Connected

Build on existing programs, local knowledge, skills and relationships. School food programs can support local food producers where possible and set local and sustainably produced food purchasing targets.



Comprehensive

Promote the values of food literacy and explore how school food programs can be integrated into the curriculum through nutrition and hands-on food systems education.



Guided by Canada-wide Standards

Ensure that programs are guided by Canada-wide nutritional standards, conflict of interest safeguards that prevent programs from marketing unhealthy food and specific products, as well as a framework for consistent Canada-wide program evaluation while at the same time being locally-led and controlled.



Committed to Indigenous Control over Programs for Indigenous Students Ensure Indigenous Food Sovereignty in a School Food Program for Canada.

Thank you for your letter to Minister Lohr regarding the impact of the housing crisis within the County of Annapolis and, in particular, the effects of the current rent cap. As the Minister responsible for the *Residential Tenancies Act*, I am pleased to respond.

I want to assure you that addressing the housing crisis is one of government's top priorities and the government is aware of the challenges being faced by both landlords and tenants. The government appreciates hearing perspectives from both parties and respects these positions in addressing the housing crisis. We also appreciate hearing different perspectives and I thank you for highlighting the specific impacts to rural communities.

On October 20, 2021 government released its housing plan <u>Solutions for housing and homelessness</u> -<u>Government of Nova Scotia</u>, which outlines a number of initiatives to address the housing crisis. We don't want Nova Scotia to become a victim of its own success. We want to make sure people can afford a place to call home and build their lives here. The measures we have announced will create new affordable housing units, improve the housing supply, and protect tenants while we take those steps. This is only the beginning. We won't fix the housing crisis overnight but we're acting now.

As a part of its housing plan, government has passed legislation to extend the current rent cap until December 31, 2023. The extension of the rent cap is not permanent and will be in place while the province supports the work to increase the housing supply. While this is being done, it is critical to maintain existing rental stock. To that end, landlords can benefit from provincial programs that can help with the costs of repairs or modifications in return for keeping their units affordable. Information on these programs can be found at "Housing Nova Scotia".

Currently, renovation evictions are banned until the end of the state of emergency or until February 1, 2022, whichever is first. In addition, the province has made amendments to the *Residential Tenancies Act* to provide additional protections for renters from renovation evictions. These amendments provide that

landlords will be required to give at least three months' notice for "renovictions", and tenants will be entitled to compensation in certain circumstances.

I am pleased you got in touch and took the time to share the concerns of both landlords and tenants in the County of Annapolis. I hope I have been able to assure you of government's commitment to improve the housing situation across the province.
