Re: Temporary Borrowing Resolution 18/19-05 for \$7,200,000

WHEREAS Section 66 of the Municipal Government Act provides that the County of Annapolis, subject to the approval of the Minister of Service Nova Scotia and Municipal Relations, may borrow to expend funds for a capital purpose authorized by statute;

AND WHEREAS clause 65(m, x, y, and acb) of the Municipal Government Act authorizes the County of Annapolis to expend funds for the purpose of the acquisition of lands and buildings for a municipal purpose, furnishing and equipping any municipal facility, providing for financing and installing equipment and containers on private property for the purposes of the supply, use, storage or conservation of water. Promotion and attraction of institutions, industries and businesses, the stabilization employment and expansion of opportunities and the economic development of the municipality.

It was moved by Councillor Heming, seconded by Councillor McNeil

THAT under the authority of Section 66 of the Municipal Government Act, the County borrow a sum or sums not exceeding Seven Million Two Hundred Thousand Dollars (\$7,200,000) in total for the purpose set out above, subject to the approval of the Minister of Service Nova Scotia and Municipal Relations;

THAT the sum be borrowed by the issue and sale of debentures of the County to such an amount as the Council deems necessary;

THAT the issue of debentures be postponed pursuant to Section 92 of the Municipal Government Act and that the Municipality of the County of Annapolis borrow from time to time a sum or sums not exceeding Seven Million Two Hundred Thousand Dollars (\$7,200,000) in total from any chartered bank or trust company doing business in Nova Scotia;

THAT the sum be borrowed for a period not exceeding Twelve Months (12) from the date of the approval of the Minister of Service Nova Scotia and Municipal Relations of this resolution;
