MOTION 200312A.01 18/19 Municipal Land and Building TBR Renewal \$7,200,000

Whereas Section 66 of the *Municipal Government Act* provides that the Municipality of the County of Annapolis, subject to the approval of the Minister of Municipal Affairs and Housing, may borrow to expend funds for a capital purpose authorized by statute; and

Whereas the Municipality of the County of Annapolis has adopted a capital budget for this fiscal year as required by Section 65 of the *Municipal Government Act* and are so authorized to expend funds for capital purpose as identified in their capital budget;

Therefore, Councillor Heming moved, seconded by Councillor Fowler,

That under the authority of Section 66 of the *Municipal Government Act*, the Municipality of the County of Annapolis, borrow a sum or sums not exceeding Seven Million Two Hundred Thousand Dollars (\$7,200,000) in total for the purpose set out above, subject to the approval of the Minister of Municipal Affairs and Housing; and

That the sum be borrowed by the issue and sale of debentures of the Municipality of the County of Annapolis to such an amount as the Council deems necessary; and

That the issue of debentures be postponed pursuant to Section 92 of the *Municipal Government Act* and that the Municipality of the County of Annapolis borrow from time to time a sum or sums not exceeding Seven Million Two Hundred Thousand Dollars (\$7,200,000) in total from any chartered bank or trust company doing business in Nova Scotia; and

That the sum be borrowed for a period not exceeding Twelve (12) Months from the date of the approval of the Minister of Municipal Affairs and Housing of this resolution; and

That the interest payable on the borrowing be paid at a rate to be agreed upon; and

That the amount borrowed by repaid from the proceeds of the debentures when sold. **Motion carried**, 10 in favour, 1 against (Roberts)
