- *UARB Decision M07376* this was essentially approved, with requested follow up. The follow up information has been submitted.
- *Basinview Centre Lease* Council has been asked to approve the assignment of the lease. The new tenant is proposing to use the same name, so the Solicitor is not sure if we need an assignment or amendment. He will advise.

TIR Lands Faye Road – the Solicitor reported he had sent draft documents to TIR but has not heard back. Motion carried unanimously.

Tickets are limited so call soon. The monthly breakfast will be held at Felker Hall, the Cornwallis Park Community Centre on Saturday, February 11th.

New Business

<u>Re</u>: Dangerous or Unsightly Premises Invitation to Tender – the Dangerous or Unsightly Premises Administrator reported that an invitation to tender to render a single family dwelling inaccessible and remove debris from around the property and stored in the accessory buildings, and render that building inaccessible, at the property of Carol Anne Myles, Inglisville, was circulated and the tender opening took place on January 13th at the municipal office in Lawrencetown. This was initially brought forward in October. One tender was received for \$7,375 plus tax. Neighbourhood concerns are that people come and go here fairly regularly. The tender invitation was for complete cleanup of the property; closing up the house so nobody can get in, cleaning out and hauling away contents of the storage building, and demolition of a third building. The property is two years in arrears for taxes.

The quote has not been accepted. There are two options: accept the quote received, or change the ask to make the property safe, knowing it would be on the 2018 tax sale.
